## Ordering Information

**Prices:** For the most current pricing, please visit our website at [www.NewAgeIndustrial.com](http://www.NewAgeIndustrial.com), AutoQuotes®, or contact the factory. Specifications and prices are subject to change without prior notice.

**Quotations:** Quotations are valid for 45 days from the date of the quotation. Changes in raw materials or economic factors are beyond our control. New Age reserves the right to increase prices with 30 days notice or at the time of the order confirmation.

**Cancellations:** Cancelled orders within two weeks of scheduled shipment are subject to a cancellation charge of 25% of the total purchase order.

**Terms of Payment:** Payment in full 30 days after shipment or C.O.D. at the discretion of New Age Industrial's Credit Department. If you are a new customer and are not listed in Dun & Bradstreet, please give us the name and address of three credit references and your bank, unless you prefer C.O.D. terms. We also accept Visa, Master Card, and American Express payments.

*Past due accounts are subject to 1.5% interest per month.*

**Damaged or Lost Goods:** It is the responsibility of the consignee's receiving agent to inspect equipment upon delivery. If you see your shipment is incomplete or damaged when you receive it make a notation on the freight bill — If the freight company will not allow you to do so, refuse shipment. If the damage is concealed, you **must** notify New Age within 15 days (including the day of delivery plus weekends and holidays). New Age will handle all claim paperwork for the customer.

**Returns:** Returned merchandise must be pre-approved with a RMA number assigned by New Age and noted on both the shipping label and bill of lading. Merchandise is to be returned with transportation charges prepaid and is subject to a 20% handling and inspection charge. New Age reserves the right to refuse the return of any piece of equipment.

**Acceptance:** Possession of Price List does not constitute an offer to sell. Orders are subject to acceptance by New Age Industrial.

**Custom Equipment:** All equipment not listed in this Price List shall be considered "custom". **POSITIVELY NO RETURNS will be accepted on "custom" built equipment.**

RAC Line products are guaranteed for one year against workmanship defects if used for its intended purpose, not loaded beyond the static load capacity and not abused, misused or altered.

## Restrictions

1. Your New Age product must be used solely for its intended purpose. Abuse of, misuse of, changes to, alteration of, or improper maintenance of original equipment shall void any warranty.
